## President's Letter

I am recently returned from the Order of Malta's "Conference of the Americas" held in Mexico City. At a meeting attended by the presidents, chancellors and treasurers from all over North and South America, we were given a report of the worldwide status of the Order as well as the charitable works being done throughout the world.

The Order of Malta has national associations, priories and sub-priories in over 50 countries worldwide, and we have diplomatic relations and Ambassadors in over 98 countries. The Ambassadors are our conduit to humanitarian aid in many of these countries. We are working with leprosy in Africa, Cambodia, Uruguay, and Thailand. We have established AIDS programs in South Africa, Honduras and Mexico. The Order distributes medicines to countries too numerous to mention. Order of Malta doctors from around the world give up their time and talent every year in Haiti, Nicaragua, Chile, Colombia, Sudan, Senegal, and Venezuela to name a few.

In addition, the Order operates hospitals in Germany, Holland, Italy, Australia, England, and the Holy Land. Palliative care is provided in every major country in Europe, the homeless are being cared for and children are being nourished and given medical care. In France, care is given to people with special needs, those with autism, the handicapped, the elderly, the destitute and the homeless.

In countries all over the world, the hand of the Order reaches out to heal, to help, to care and to give solace. It is remarkable that in a world of 6.6 billion people, a little more than 12,500 Knights and Dames have accomplished so much in the name of our Catholic faith.

When I reflect upon the works of the three U.S. Associations I am amazed at what has been done in the name of the Order. The three U.S. associations work together on projects like the hospital in Maillot, Haiti, rebuilding homes in New Orleans, and providing for single mothers in Dallas. We have also provided funding for a respiratory care center in Chile—aiding yet another one our sister Associations.

I am pleased to report that our Federal Association continues to grow in membership and activities. In October we invested 58 new Knights and Dames, and our candidate class of 2008 numbers almost 80 very qualified men and women from around the country. Our Admissions and Formation committees do an excellent job of reviewing and assisting our candidates. These good-sized classes of quality people speak to the strength of the Order and the Association.

Our Regional Hospitallers continue to do great work, keeping our members busy in all of our regions nationwide. I am so pleased that there is a regular, monthly Mass for our members in all of our regions, and that there are so many good and meaningful volunteer projects in which our members and their families can choose to participate. I am also very pleased to report that all four of our weekend spiritual retreats were wellattended and well-received in 2007. The weekend retreat is a wonderfully relaxing and refreshing experience, and I am grateful to our Retreat Committee and our confreres in Jacksonville, Baltimore, Pittsburgh, and Charlotte for working so hard to make this retreat experience available to so many of our members and candidates.

The most meaningful experience of the year for me was not to be found in any publication or on any calendar. It was the experience of witnessing, from afar, the beautiful, quiet way that our Knights and Dames took care of one of their own - our own - in her last months, weeks, and days. Ligia Remick, DM, was one of Baltimore's most active members and was a mainstay on the Lourdes Pilgrimage. In 2007 she returned to Lourdes, this time as a Malade in rapidly declining health. The pilgrimage was difficult for her; and several doctors, nurses, and others had to work together to help Ligia through the week. Her return to Baltimore would have been even more problematical were it not for the kind, loving and heroic actions of our Baltimore Knights and Dames, the doctors, nurses, chaplains, financial planners and many others who helped make Ligia's final weeks a time of comfort and peace.

Allow me to quote Archbishop Wuerl as he closed his homily at our Investiture Mass in October, "Every time we look at the cross, every time we look at the cross of Malta, may we be reminded that we bear it with great pride, individually, and as an order, because we know that we share in the great work of the Church. We share in Jesus' ministry of making known the love of God, of making it present in our world through what we say and the deeds we do."

Please remember fondly and pray for Ligia and all of our beloved confreres who have died this year, and let me take this opportunity to thank you for your dedication and service to the Order. On behalf of the Federal Association and those we hope to serve – thank you very much.



# Chaplain's Report



## INVESTITURE WEEKEND 2007



# Hospitaller's Report

The Regional Hospitallers met twice in 2007. Our first meeting was in March in New Orleans, and the second was in Washington on the Thursday before Investiture in September. What was clear at both of these meetings is that our members are very busy serving the poor and the sick in dozens and dozens of projects nationwide.

### Some of our projects are big –

Over 100 Knights, Dames, and candidates volunteered for one of the five work weeks in New Orleans in 2007 as part of our Hurricane Katrina Home Renovation Program. Ozzy Marcenaro continues to do yeoman's work as the project manager and volunteer coordinator, and several of our members and candidates have been down to NoLa to work two and three times.

Over 150 Knights, Dames, candidates, and auxiliary members participated as volunteers in the 2007 pilgrimage to Lourdes. Led by John Miller and the fantastically dedicated Medical Team led by Dr. Jacek Mostwin and Mary Noel Page, our members took a total group of 296 people from all around the country to Lourdes for a week of prayer, good fellowship, and healing.

### Some of our projects are new –

In 2007 many members of our Association explored the possibilities of visiting and providing some service to our wounded troops returning from Iraq and Afghanistan. Working through the red tape at the V.A. hospitals has, at times, been challenging, yet an intrepid group of our members and Auxiliary members in Washington and Baltimore have arranged two trips to Orioles games



(luxury box, bus, special treatment throughout) for wounded soldiers, and their families, staying at Walter Reed Hospital in Washington.

Another new initiative has been the thrift shop at the Plaza San Juan Bautista in Lancaster, Pennsylvania. All of our Knights and candidates there have been very involved with the fund raising necessary to renovate and re-open the shop, and they remain committed volunteers.

# And some of our projects just keep going and going –

Of the many and varied projects supported by our Knights and Dames nationwide, one might suspect that Project SHARE—which requires our volunteers to report at 5:00 am on Saturdays—would be the least well-attended. Yet, the exact opposite is true—a further illustration of the dedication of our members. Thanks to the tireless dedication of veterans like Jim Belson, Jay Jagoe, and Jim Treanor and the energy of new members like Julian Flores, Joan Conley, and Adam Carter the volunteers from the Federal Association continue to show up once a month, at dawn, to help put together and distribute the bags of food that will be given to the hundreds of families who will pass through that day.



Over the years, hundreds of Federal Association members have volunteered thousands of hours at our assisted living facilities in Washington, Syracuse and New Orleans. Every month at Malta House in Syracuse there is a birthday/holiday party and a first-Monday Mass organized by two different members of the Association. Kathy Mezzalingua is the Regional Hospitaller and gives all the Knights and Dames their assignments for the year. In addition to the parties, Dr. Al Falcone still hosts the ever-popular "Conversations with Alfredo" program.

The pilgrimage can be physically and emotionally draining for our malades—but our numbers are always ready to assist with a smile, a shared prayer, or a listening ear





# Grants Committee *Report*

In 2006, the Association's Grants Committee and the Task Force on Cuba awarded over \$2.3 million in support of our international and domestic grants programs. This includes over 1,250,000 worth of food, medicines, and other supplies through our in-kind donation program. This program has a multiplier effect of 1:5 - so that, for every dollar the Association spends, we provide five dollars worth of food, medicine, supplies and material. It is through this program that we also support our expanding domestic clinic program.

The final numbers are not in yet for 2007, but as the list of projects shows, our Association was able to offer support with funds or materiel to 40 projects in this country and internationally.

# PROJECT LIFELINE

Many think that HIV/AIDS or other diseases such as malaria are responsible for the suffering and dying of children around the world. In truth, disease accounts for only 3% of the 9.7 million deaths of children under the age of five. Though child mortality has fallen below the 10 million mark worldwide for the first time in a decade, the very young continue their struggle against basic childhood illnesses: measles, diarrhea, upper-respiratory infections, parasites, dehydration and malnutrition. Few guess that for well under one dollar, each of these conditions can be treated successfully.

In 2000 the Federal Association began a partnership with an organization called Medicines for Humanity. Medicines for Humanity's mission is to save children in impoverished countries worldwide. Its premiere program, Project LifeLine, helps increase the survival rates of children through the age of five. As an international program, Project LifeLine focuses on established, dependable partners in impoverished countries in order deliver medicines on a reliable schedule to children and women. It is able to work fluidly by finding reputable clinics with well-trained staff willing to work within the program's objectives. Projects last roughly five years to help children through those most vulnerable early years.

The Federal Association sponsored its first Project LifeLine site January 2000, collaborating with the Daughters of Charity in Haiti. The Daughters operate a pre-school and grade school within a compound which is located in the middle of a 300,000 person slum near Port-Au-Prince. Anyone who finds themselves sick in the slum has little chance of being treated, especially newborns and mothers. Thankfully the Daughters operate a clinic twice a week within the compound walls. When Project LifeLine and the Daughters started in January 2000 both projected serving 10,000 mothers and children in the first year. Amazingly, over 24,000 patients arrived in the clinic in the first six months once word spread in the slum. Today, despite the turmoil that surrounds their compound, the clinic continues to treat large numbers of patients— over 24,700 patients visited from January through June of this year. In it's final year of support, the Federal Association will help continue to guarantee the purchase of medicines as simple as dehydration salts—doses which cost as little as 42 cents a pack help counter-act the ravages of diarrhea. Dehydration, due to diarrhea, can be mortal to infants and toddlers in Haiti. With a few dollars, tens of thousands of doses have been distributed in the last seven years through Project LifeLine-Haiti.

Project LifeLine-Dominican Republic distinguishes itself by being a mobile clinic. Launched in 2004, it serves two bateys or work camps. Each camp has 10,000 residents. Two to three times a week doctors and nurses travel into the work camps, visit out-posts, and perform pre-natal visits, de-worming and vaccinations. In 2007, over 7,600 women and children have been seen and close to 15,000 children have been treated for parasites and dosed with vitamin A, which helps to prevent early childhood mortality. Here again, a donation of \$15,000 a year purchases over \$116,000 worth of medicines. And as few as two, pre-natal tetanus shots at 20 cents each helps keep a baby safer at birth. Over 1,600 women and 42 pregnant women have been visited this year in the bateys.

# Treasurer's Report

During 2006, the total assets of the Federal Association of the Order of Malta grew to \$4,103,224, which was an increase of 8.9% over the previous year. The cash and cash equivalents was \$647,069 at year-end, which was \$39,290 more than 2005 year-end. The increase was due, in large part, to the timing of the distribution of our grant commitments. Also over \$390,000 of the cash and cash equivalents is money designated for the hurricane relief program, which was spent in 2007. The support and revenues in 2006 for the Association were \$4,124,737. This amount was lower than the previous year by almost \$970,000. This difference was due to the lower amount of in-kind contributions during 2006. The demand for food supplies, which make up a large part of our in-kind contributions, was less than in 2005 than in 2006. Still in 2006 our in-kind contributions totaled \$1,257,980.

The annual membership dues continue to cover the Association's operating costs (payroll, rent, publications, etc.) and most of our other activities are budgeted to break-even. Great efforts have been made in the past year to get the annual pilgrimage to Lourdes closer to a break-even position.

In 2006, our members donated \$779,000 to the Annual Fund, and we received almost \$745,000 for the 2007 Fund. All of the 2006 Appeal funds funds were allocated to and spent by the Grants Committee, the Task Force on Cuba, the Association's nationwide Clinic Program, and the Defense of the Faith Committee. Dozens of grants and allocations were made by these committees throughout the year, and the total list, found in the Hospitaller's Report, is a great testament to generosity of so many members of our Association.

The Investment Committee is comprised of Thomas Roddy as chairman, assisted by B. Francis Saul, Agnes Williams and John Williams. This committee receives professional investment counsel from the firm of deGarmo & Kelleher in Washington, DC. The investment portfolio is a fairly conservative mix of stocks and bonds and it shows modest growth reflective of current market conditions.

For the calendar year-end 2006, the Federal Association of the Order of Malta had an audit conducted of the financial statements and related statements of activities and cash flows by the firm of Councilor, Buchanan, & Mitchell. The auditors declared this a "clean" audit and were satisfied with the Association's financial records and record keeping procedures. Copies of the complete audited financial statements and supplementary information are available in the Federal Association office.
