


I'm reminded of our journey as members of the Order and I am encouraged to ask myself how I'm doing on my own spiritual journey.



President's Message

ear Fellow Members of the Federal Association:

I am pleased to present to you the 2010-2011 Annual Report for the Federal Association of the Order of Malta. During the past year, much has been done and this report is intended to give you an overview of the various good works of the Association, of our regions and of our members in service to poor and sick and in defense of the Catholic Church. So much of what we do as members of the Order of Malta is done in community with other knights and dames, candidates, chaplains, auxiliary, spouses and friends.

Throughout the year many events call us together as knights and dames of the Order: the Day of Formation, the Lourdes Pilgrimage, the feast of St. John the Baptist, the Investiture weekend, Masses for deceased members, our Defense of the Faith forums, regional meetings. Much of the work we do in our communities is done in a very quiet way, with

generous hearts and great concern for the infirm and poor that we serve. For every story and photo which appears in these pages there are hundreds of other servant leaders in the Order whose names are not mentioned. Each of us contributes to the work of our Order, but each of us needs to go beyond what we have done thus far because there is so much more to do.

Each year, our Annual Appeal supports many charitable projects throughout the regions which are important to our mission. Not only are we assisting service projects, but Appeal funds are used to support grants for our Defense of the Faith efforts. All of these projects and contributions are made by the recommendations of the Grants and the Defense of the Faith Committees. The requests for the vast majority of these grants are initiated by applications members submit with their testimony about the essential services these programs provide to the poor in their regions. It is important that every member participate in the Annual Appeal, the Order's life blood for the Grants programs.

As you know, several of our members have made the promise of Obedience and are members in the Second Class. This distinction is granted to those knights and dames who dedicate themselves to a deeper spiritual commitment. Presently we have 25 members in the Second Class and encourage other members to consider this calling. We are also pleased to announce that this past year Fra' John Harvey made his initial vows to become a Knight of Justice. We are particularly happy about this event since our professed knights are our connection to the ancestral roots as an Order of the Church.

This year we made several organizational changes within the Association to improve communication and to enhance our member's ability to serve others. A By-laws Task Force and a reorganization task force for the Regions completed their work and 2012 is the year for implementation of the changes. We hope that the changes will help you in your service to the Order and to the poor and sick.



The true story of our Order and the Federal Association is that the work mentioned here is multiplied exponentially by our members, and the impact we make in our communities is significant beyond these pages. And so, perhaps in a simple way, we individually—and joyfully—take part in the work of the Order by offering the words of our Daily Prayer: to promote God's glory, the World's peace and all that may benefit the Order of St. John of Jerusalem. Treasurer's Report

espite continued weakness in both the U.S. economy and financial markets, the Federal Association ended 2011 in sound financial condition. A record number of our members supported our grants program by contributing \$836,627 to the Annual Appeal, an increase of nearly 7% over the 2010 total. This year's average gift of over \$1,300 is in line with the levels of previous years. Thus, we are making progress toward but are still well short of achieving 100% participation. The Annual Appeal is the primary funding mechanism for the Grants Program which focuses our support of the many worthy projects around the Federal Association's geographic footprint. Please continue to make this a priority in your charitable giving.

In another area of emphasis, we added seventeen new members to the Blessed Gerard Society, bringing the total to sixty. This group of dedicated Knights and Dames who have included the Order of Malta in their

estate plans represents the key driving force in building our resources to allow for the ongoing long-term support of our programs, including Defense of the Faith and the annual Lourdes pilgrimage.

The accompanying table provides the detail of our financial status for the year ended December 31, 2011. Because this report is published earlier in the calendar year, we are just beginning this year's audit cycle. As such, we currently have only unaudited data available. When the audit is complete, the entire report will be available on the Federal Association web site.

ow do the knights and dames of the Federal Association live out their solemn promise made at Investiture to serve the sick and the poor? As individuals they do so in countless ways every day. As members of the Order, their contributions to the Annual Appeal provide direct services to the needy in our hospitaller regions, as well as in several

locations in Central and South America and the Caribbean Basin. By pooling their generous donations, members have significant impact on programs the Federal Association supports.

Members of the Grants Committee serve as stewards of these donations. Twice a year, twelve members from different hospitaller regions

meet to recommend to the Board the applications for charitable programs that have been submitted by members of the Federal Association. Prior to that meeting, each grant has been assigned to a committee member to determine whether each grant meets the grant guidelines. The entire committee then convenes to vote on their recommendations to the Board approve or deny the grant applications.

In 2011, the Federal Association supported a wide variety of programs, focusing especially on those in which knights and dames are actively involved. It is an overriding principle of the Grants Committee that we should have "our treasure follow our time and talent." There are just a few examples noted here. Please review the entire list (printed on the next page) of grants made possible by knights' and dames' donations.

2011 Domestic Grants

Our grant of \$25,000 will enable Holy Angels Foundation in Charlotte, NC, to purchase five more lifts and 30 slings to accommodate their bed-bound patients who cannot turn themselves. Holy Angels enjoys the support of many local members. \$25,000 given to Christmas in October in Kansas City, MO, paid for about 170 ramps for wheelchair-bound poor, so elderly persons can have easier access to their homes. This program has involved virtually every knight and dame in the regions. Several of our members bring meals and offer companionship to the "Core members" (the severely mentally disabled) of L'Arche of Washington

and Virginia, so this year we offered a matching grant of \$17,500 to make a bathroom handicapped-accessible in a L'Arche home which provides lifelong care. We were pleased to make a \$25,000 commitment to a new home being created by the Brothers of Charity in Washington, DC, for homeless veterans. Members' support enabled us to purchase a van for St. Vincent de Paul in southern Maryland, and to contribute toward the cost of another van needed to transport the elderly and disabled of Malta House and other nursing homes of the Washington Archdiocese.

2011 International Grants

Honoring the request of the Grant Master, we have focused our International grants on the Caribbean Basin and Central America. Eight

grants totaling over \$132,000 benefited that area; among them, a \$25,000 contribution to the annual medical mission to Nicaragua undertaken by knights and dames of New Orleans, LA. Contributions of \$25,000 each went to Medicines for Humanity and Catholic Medical Mission Board, both of which have excellent records of maximizing the purchasing power of every dollar they receive. CRUDEM in Haiti received \$25,000 to provide care for the poor in L'Hopital Sacre Coeur, where several of our doctors practice for a few weeks every year. A grant of \$5,000 allowed Sisters of Mercy in Panama to purchase sewing machines and computers to teach poor single mothers how to become more self-sufficient.

The 2011 Clinics Program

The Diabetes Initiative spent \$27,500, providing about \$60,000 worth of testing strips and meters to encourage poor diabetes patients to monitor and control their disease more effectively. The balance of the funds was primarily used to fund grant requests for medical assistance. At the end of the year, the clinics program was consolidated into the Grant Program.

Knights and Dames may never know just how many persons have been touched by the generosity demonstrated in gifts to the Annual Appeal, but it is a certainty that what we have given will indeed make a difference in countless lives. Thank you for your continued support.

ach week members of the Order in the Federal Association bring to life our Daily Prayer of the Order by dedicating themselves to regular hands-on service to the sick and the poor. Much like our founder, Blessed Fra' Gerard, and the knights in the hospital in Jerusalem, members across the 23 regions offer medical services, meals and perhaps most importantly, friendship. As members of the Order, at Investiture Mass, we commit to this enlistment for service to others in a hands-on way.

If you are not already working at one of the Federal Association's projects in community on a regular basis, please consider increasing your commitment each month with the goal of serving on a weekly basis. While there are many weekly opportunities to participate in the life of the Order including attending regional Masses, retreats and gatherings, there is no substitute for weekly hands-

on service to the poor. Each region has a need for members to serve on committees, help organize local events, participate in work projects and to seek opportunities for members to work in community serving the sick and the poor. Contact your regional hospitaller and offer to help!

Our Grants Committee awards monies from our Annual Appeal to our regional projects where our members serve regularly in a hands-on way. Investing in the projects where our members volunteer encourages greater participation and allows our treasure to follow our time and talent. Members of the Federal Association have been exemplary in the commitment to serve. Here are a few examples of members in regular service to our lords the sick and the poor:

In Syracuse, Pat Fallon is a willing volunteer. Kathleen Mezzalingua says that no matter what project the group embarks on Pat involves herself. The Syracuse region divides the year into months rotating responsibility for assigning tasks to volunteers, coordinating the works and attending to the

details of the projects for those months. Pat volunteers in nearly every service role and project in the region from monthly pancake breakfasts to the defense of the faith projects. She steps in to fill the increased need when several of the Syracuse members are away for an extended time during the winter. Pat takes her commitment to the Order seriously. She sets a wonderful example as the mother of seven and grandmother of 40 grandchildren in her exemplary works as a Dame in the Order.

In Hartford, Jean-Pierre van Rooy says that undoubtedly Dr. Pauline Olsen is the one of our members who represents to the utmost the weekly service to the poor and the sick. Except when she is on an out of town trip, she is always busy helping the poor and the sick either as a medical doctor at the Malta House of Care since its beginning on weekly duty or more when an additional doctor is needed, or helping in case of need at the St. Gerard Center for Life. Pauline is now creating from scratch with the help of other members, the Malta Food Pantry at the St. Justin Church of Hartford that will most probably open in April.

In Montgomery County, MD, Anthony Falcone and Shep Abell have volunteered at the Gift of Peace each Thursday afternoon for years. They gather in community with the male residents to pray the Rosary, share prayer intentions, have a meal and enjoy the gifts of friendship. Shep also ensures that each winter, a television is set up for the men for a few hours to allow them to watch the Super Bowl as a change of pace from saints biographies. The Grants Committee recently funded boiler repairs and general maintenance to the facility.

At Malta House, an assisted living facility near Washington, DC, Joan Desmond and Joan Glasgow gather each Wednesday with the residents for spiritual enrichment in the form of a chapel service and Rosary. Seminarians participate weekly from Mt. St. Mary's Seminary to work on their homiletic skills as part of their priestly formation. The residents look forward to

these visits as it provides them a prayer community and a link with young seminarians and members of the Order. Last May, a resident joined us on our pilgrimage to Lourdes as a malade and Malta House volunteer Valencia Camp volunteered to be her companion. The Grants Committee helped to fund a van for outings for the residents.

In Chicago, Ted Milos works regularly and diligently at the Mission Outreach project sorting and packaging medical supplies for clinics in developing countries. The Chicago region adopted this project to serve the sick and the poor and to prevent tons of wasted supplies from ending up in landfills. The sorting room has bins for each type of supply. Each item has to be carefully checked for expiration dates, proper packaging and general usefulness. As the bins fill up, the items are catalogued, dated and boxed to await orders from clinics in South America and the Caribbean Basin. Last year the Grants Committee helped to fund a large truck to collect supplies from

Chicago area hospitals and clinics. Ted also volunteers at the St. Thomas soup kitchen ministry of the region. As Sam Cicarelli says, Ted is always present quietly working in service to the poor often with his wife and two children who are members of the Chicago Auxiliary.

We are reminded, as members of the Order, in the recently released Regulations and Commentary Article IV no 4 under the heading Participating Concretely in the Works of the Order "to devote oneself to the charitable activities of the Order" is an essential part of a member's duties ... The generosity of the members of the Order should manifest itself, preferably in the charitable activities of the Order itself. Of course, the fullness of participation is achieved when one has direct contact with our lords the sick and the poor.

In 2011, the Board continued to review the organization of the Federal Association and its Regions. In particular, the Board considered and approved recommendations to formalize the process for the development of Regions—both for established Regions and new, developing areas.

As shown in the charts, the standards approved by the Board are intended to help guide the evolution of Regions from the beginning of their life cycle. The standards also strive to make clear the minimum requirements necessary to become an official Region. In particular, the Board thought it important to have a certain critical mass in a geographic location before it can become a Region. Also there must be a visible dedication to hands-on service work in the location as well as a plan to find additional candidates for the Order so that the Region can sustain itself.

he past year's Lourdes

Committee Provides Programs and Funds Activities

While Defense of the Faith, *Tuitio Fidei*, has been one of the two charisms of the Order of Malta from its beginning 900 years ago when members of the Order wielded swords to defend the faith, today knights and dames are called to employ more modern means.

In 2011 the Defense of the Faith Committee tried to provide those means by educating knights and dames about their Catholic faith and about contemporary challenges to it and by supporting member-sponsored Catholic organizations which promote and defend the Catholic faith in the world today.

In this way the Defense of the Faith Committee assists knights and dames to fulfill the promise they make in the Daily Prayer of the Order: Be it mine to practice and defend the Catholic, the Apostolic, the Roman faith against the enemies of religion.

Education

The committee produces two educational programs each year for the entire membership. The spring program of general faith education is designed to inform and strengthen the faith of members in the many regions where they reside. The fall program during Investiture Weekend when all members come together in Washington, DC, aims to educate members about a contemporary issue which is challenging Catholic beliefs and practices.

In 2011 the committee's two programs were: Living Your Faith: Living Out the Compendium of the Catechism of the Catholic Church Through Education, Defense of the Faith, and Ministering to the Sick and the Poor, and Passing the Faith to a Younger Generation.

The spring program, Living Your Faith, in the form of a DVD video series and a printed companion guide, was sent to regional hospitallers for use in regional small groups of knights

and dames. Produced by the American Association, the DVD consisted of four 30-minute film segments. Each segment portrayed a particular work of the Order of Malta and a discussion by theologians from The Catholic University of America of the key Catechetical themes which the work illustrates. The companion guide, produced by the Federal Defense of the Faith Committee, attempted to stimulate reflection on Scripture and on membership in the Order and to give references for further reading.

Sixty-six DVD's and guides were mailed to the 23 regional hospitallers. Also, the companion guide was posted for download on the Defense of the Faith page of the association's website.

The fall program, a panel discussion of "Passing the Faith to a Younger Generation", took place on Friday, October 21, in Washington, DC. Two hundred and seventy knights and dames attended. Panelists compared the beliefs and practices of older Catholics with those of current young adults, talked about the personal faith journeys of particular young adult Catholics, and discussed what the Church is doing to attract young adults to Mass and the Sacraments. Panelists were: Rev. Thomas Gaunt, S.J., Executive Director of the Center for Applied Research in the Apostolate; Helen Osman, Secretary of Communications for the U.S. Conference of Catholic Bishops; Rev. Gregory Shaffer, Catholic chaplain at The George Washington University;

This comment came from a listener who learned about the Order of Malta from radio broadcasts of The Catholic Café, a signature project of the Memphis, TN, hospitaller region.

The Federal Association through the Defense of the Faith Committee provided funding for The Catholic Café to go "on location" to the 2011 Lourdes Pilgrimage to produce shows on the work of the Order and other Catholic topics. Eleven 30-minute segments were produced in which the Grand Master, the Grand Hospitaller, two Ambassadors of the Order, and representatives of Malteser International talk about the Order, its works, and its pilgrimages. Other Federal members discussed Catholic bioethics, Catholic higher education, and Catholic Charities. These

The mission of the Catholic Café is to faithfully present Catholic teaching in an accessible, talk format for non-Catholics, former Catholics, and the poorly cathechized. The other mission is to broadcast accurate information about what Catholics believe in order to combat misinformation common on the airwaves. Including both doctrinal and devotional topics, recent programs have included Personal Devotion to Jesus, the New Evangelization, Discerning the Priesthood, the Erosion of Religious Freedom, The but sadly I was not raised in the Church and Science, the Problem of Evil, and Suffering and Healing.

The show airs weekly on four radio stations in the Diocese of Memphis and one station in Hartford, CT. It is syndicated on 37 stations throughout the U.S. by Relevant Radio. Shows are available free of charge on the internet

for listening and downloading, and links are offered for those wishing to delve into a topic more deeply.

The Catholic Café receives letters from fans around the globe, including:

A Message from the Regent of the Subpriory of Our Lady of Lourdes

A Deeper Commitment to the Order of Malta Through the Promise of Obedience

he Subpriory of Our Lady of Lourdes was established by H.M.E.H., the Prince and Grand Master, with the approval by the Sovereign Council in 2006. Hence, we have celebrated our fifth anniversary year. There are two subpriories in the United States, the first being the Subpriory of Our Lady of Philermo, founded in 2002 and whose territory is that of the Western Association of the Order of Malta. The territory of the Subpriory of Our Lady of Lourdes encompasses that of both the American and Federal Associations.

We in the Subpriory of Our Lady of Lourdes, following our Confreres and Consoeurs in the Subpriory of Our Lady of Philermo, wish to assist our Members, Knights of Justice and Knights and Dames in Obedience, in fulfilling their spiritual obligations and in being a strong, shining light to members of the Third Class in the development and practice of their charism and spirituality.

Recent Membership Activity in the Federal Association

In both 2010 and again in 2011 a member of the Federal Association made the Promise of Obedience. Two members of the Federal Association are currently in the year of preparation to make their "Promise." There are currently two Knights of Justice from the Federal and the American Associations, and in 2011 a member of the Federal Association, Fra' John Harvey, made his first Temporary Vows as a Knight of Justice, and a second member of the Federal Association has been approved by the Sovereign Council to enter the Aspirancy to the Novitiate for the First Class.

What is Obedience?

Members of the Subpriory in the Second Class make the "Promise of Obedience." It is between the vows of the Professed Knights of the First Class and the commitment of the Knights and Dames of the Third Class. Knights and Dames of Obedience "promise:" To live a life leading to Christian perfection in the spirit of the works of the Order;

To attend Mass frequently and to recite certain daily prayers;

To take part in annual spiritual exercises, including a 3-day retreat each Year.

As Fra' John Dunlap, a member of the Sovereign Council wrote when he was the first Regent of the Subpriory, "Being admitted to the Second Class (Obedience) is not a promotion nor is it an honor. It is a commitment to a deeper personal spirituality within the Order and availability to perform further duties for the Order." I would add that the Subpriory is a "spiritual family" within a larger family which is the Order of Malta, a statement found in the 2011 Regulations and Commentary on the Order of Malta.

I would also ask us to remember to serve all our fellow members in the Associations and to work behind them in serving the sick and poor. We can take no precedence as servants of our Lords, the sick and poor.

What is the Nature of the Promise?

The Promise we make (to be Obedient) is close to the vow made in a religious order. It is greater than a commitment in a pious community of prayer. It is an innovation within the norms of the Church; it is close to the obliging nature of vows of a religious order. (Regulations and Commentary).

The Promise entails an obligation to hear and act upon the Word in every hour and every day! It is, indeed, joyful and is intended to bring happiness of the soul. I would like to add that we

make the "Promise" to God, and only indirectly to our Superiors in the Order, whether it be to the Prince and Grand Master, the Grand Commander, or to the Regent or his delegate. While they, indeed, are our religious superiors within the Order, they are only instruments of the Lord Himself.

The Promise can also be described (as it is in the Regulations and Commentary) as a bilateral obligation between the candidate and the Church, with the superiors of the Order representing the Church; thus the obligation is with God.

Membership in the Subpriory, then, is membership in a religious community, and those who enter make an open profession to follow the path to perfection in the community of a Subpriory. Within this community, we seek what is useful to others, to love each other unselfishly, and to be brothers and sisters in the same family.

Membership

The Subpriory currently has 51 Knights and Dames in Obedience, 28 from the American Association and 23 from the Federal Association; 17 Knights and Dames are now in a year of preparation before they make their Promise. The Subpriory is also the spiritual community of our four members who have made their perpetual vows as Knights of Justice, a member who has made his first Temporary Vows, and a member whose petition to enter the Aspirancy to the Novitiate for the First Class has been approved by the Sovereign Council. (It is the special mission and duty of the Subpriory to encourage vocations to the First Class).


Chaplains

The Subpriory of Our Lady of Lourdes has two Chaplains. The Principal Chaplain is the Very Reverend John McGuire, O.P., Conventual Chaplain of the Order. The Assistant Chaplain is Monsignor James Watkins, Magistral Chaplain. Father McGuire is Pastor of St. Joseph's Church, New York City, and Msgr. Watkins is Pastor of the Immaculate Conception Church, Washington, D. C.

Process for Admission to Membership in the Second Class

A Member interested in pursuing Obedience begins by writing to the President of his or her Association requesting permission to go forward. If approved, the President forwards the candidate's application papers to the Regent. Thereafter the application is reviewed by the Council of the Subpriory and, if approved, the Regent writes a letter of support to the Grand Commander asking His Excellency to approve the candidacy and to put the Petition before H.M.E.H., the Prince and Grand Master, and their Excellencies, the Members of the Sovereign Council. It is the Grand Master, with the consent of the Sovereign Council, and a "Nihil Obstat" from the Prelate of the Order who admits a member to the preparation period and who will after the end of the year of preparation who will, in the same manner, welcome a new Knight or Dame in Obedience into the Second Class of the Order.

It is the Regent's role to help the candidate prepare for a year of prepa-



ration which begins with a five-day retreat at a retreat house approved by the Regent. A spiritual director for each candidate is appointed to assist the candidate in the year of preparation.

Governance of the Subpriory

Pursuant to its Bylaws, the Subpriory is governed by a Regent, who is assisted by a Council, consisting of a Vice-Regent, Chancellor, four elected Councilors, and two ex-officio Councilors, the Presidents of the American and Federal Associations. The Regent and the Councilors serve six year terms and are elected by the Members of the Subpriory. The line of authority to the Subpriory within the Order of Malta comes from His Most Eminent Highness, the Prince and Grand Master, through His Excellency, the Grand Commander to the Regent of the Subpriory.

Interdependence of 'Obedience' and 'Community'

We in the Subpriory are a community of prayer, but we are also very much a part of the larger community of the Order with whom we are called upon to serve. We are a reminder that we are a lay religious order and that we are all called upon to make a deeper commitment to serve the sick and poor and witness the Faith.

Recognizing Those Who Have Received Special Awards as Members of the Order of Malta

hree members of the Federal Association were elevated to Grand Cross of the Order and eleven members of the Federal Association received the Order's Pro Merito Melitensi awards during the year 2010 and 2011. This Knightly Order of Merit or Order Pro Merito Melitensi, established in 1920, recognizes those whose activities have conferred honor and prestige on the Sovereign Military Order of Malta. The Order's Sovereign Council confers these awards to members and non-members of the Order of Malta. Our Federal Association establishes a Committee on Awards and Decorations to identify and recommend to the

Association's President those persons deemed most worthy of special recognition by the Order. The Grand Master can also grant these awards *motu proprio*.

During the pilgrimage to Lourdes, His Most Eminent Highness the Prince and Grand Master, Fra' Matthew Festing promoted a member of the Federal Association, and of the Subpriory of Our Lady of Lourdes, Fra' James-Michael von Stroebel, to Knight Grand Cross of Justice. His Highness recognized Fra' James-Michael's years of service to the Order, including the promotion and development of vocations to the First Class and the establishment of the Subpriory joining members

of the American and Federal Associations. There are nine Knights Grand Cross of Justice who hold this second highest honor in the Order. Fra' James-Michael is the only Knight Grand Cross of Justice outside of Europe.

At the 2011 Investiture weekend, members of the Federal Association and members of the Subpriory of Our Lady of Lourdes, W. and Joseph and Kathleen Cupo, a young couple who completed the Landings Program for returning Catholics.

A podcast of the program is available on the Defense of the Faith page of the Federal website, along with the committee's 2010 fall program, "The Erosion of Religious Liberty in America."

Email Alerts

Defense of the Faith email alerts inform members about particular challenges to Catholic beliefs and practices, so that they as individuals can give effective personal witness to their faith in whatever way they deem appropriate.

In September, 2011, at the request of the U.S. Conference of Catholic Bishops (USCCB), the Association informed members about the endangerment of freedom of conscience for health workers in federal regulations proposed by the U.S. Department of Health and Human Services (HHS). Members were referred to background information provided by the USCCB and to the bishops' request that all Catholics nationwide contact HHS and their elected representatives.

Grants

The Defense of the Faith Committee welcomes grant requests from membersponsored organizations which promote and defend the Catholic faith in the world today. Grants have been made to regional hospitallers for Defense of the Faith programs in their regions. Other grants have helped Catholics in vulnerable faith situations, such as those considering vocations to the priesthood and religious life, young adult Catholics studying their faith, Catholic military personnel practicing their faith in war zones, and prison chaplains ministering to the incarcerated. Grant guidelines and an application form can be downloaded from the Federal website.

Between October 2010 and December, 2011, the committee received and considered sixteen grant applications. Eleven grants were recommended for approval by the Association's board of directors.

While the committee ordinarily limits grants to \$10,000 or less, in 2011 an urgent request by the U.S. Conference of Catholic Bishops to all three U.S. associations of the Order

prompted the committee to recommend that the association grant \$50,000 in Defense of the Faith funds to the USCCB for the bishops' new Ad Hoc Committee on Religious Liberty. This committee will advise church leaders as they strive to defend the constitutional right to religious liberty presently under attack in federal and state governments. Comprised of several bishops and distinguished expert consultants, the committee includes two members of the Federal Association. It will consider government actions in light of constitutionally-protected rights, will conduct campaigns to inform the public, and will advocate in legislatures for the restoration of religious liberties.

In this manner, our members ensure that the Federal Association will continue to perform the work of the Order.
