



THE DECREE - PIE POSTULATIO VOLUNTATIS

*The most treasured document in the Archives of the Order
in the National Library of Malta*

MANUSCRIPT 2013

To celebrate the 900th anniversary of what is, arguably, the most important event in the history of our Order, a contemporary adaptation of the document has been produced as a limited edition of 150. It is written in a 20th century script - an adaptation of the Caroline miniscule, similar to that used in the original decree. It simulates the illuminated manuscript presented to HMEH the Prince and Grand Master on Founder's Day 2012.

The body text is printed by giclée - a fine-art form of digital printing, using pigmented inks. The illuminated lettering, arabesque motifs and circlet components are then added, individually by hand in 22ct gold.

The substrate is goatskin parchment paper, a durable watermarked rag-content paper; both the ink and paper are of archival quality. The original seal or bulla, was suspended from a red silk cord; a double seal is debossed on a special medium to portray both faces of the original lead seal.

As each document is hand-printed and requiring several hours of dedicated attention, only a limited number will be produced.

Omnia ergo que ad sustendas peregrinorum et pauperum necessitates vel in Ierosolymitanæ ecclesie vel altarum ecclesiarum parochiis et civitatum territoris per tue sollicitudinis instantiam eidem Xenodochio acquisita, vel a quibuslibet fidelibus viris oblata sunt, aut in futurum largiente Deo offerri, vel altis iustis modis acquiri contigerit, queque a venerabilibus fratribus Ierosolymitanæ ecclesie episcopis concessa sunt tam tibi quam successoribus tuis et fratribus peregrinorum illic curam gerentibus quiete semper et integra conservari precipimus. Sane fructuum vestrorum decimas, quos tibi liber vestris sumptibus laboribusque colligitis, preter episcoporum vel episcopatum ministrorum contradictionem Xenodochio vestro habendas possidendasque sancimus. Donationes etiam, quas religiosi principes de tributis seu vectigalibus suis eidem Xenodochio deliberaverunt, ratas haberi decernimus. Obvinte te nunc eius loci provisorum atque preposito, nullus tibi qualiter surreptionis astutia seu violentia preponatur, nisi quem fratres ibidem professi secundum Deum providerint eligendum. Preterea honores omnes sive possessiones, quas idem Xenodochium ultra seu citra mare in Asia videlicet vel in Europa aut in presenti habet aut in futurum largiente Domino poterit adipisci tam tibi quam successoribus tuis hospitalitatis pio studio imminutis et per vos eidem Xenodochio in perpetuum confirmamus. Ad hec adicentes decernimus ut nulli omnino hominum liceat idem Xenodochium temere perturbare aut eius possessiones auferre vel ablata retinere, minuere, vel temerarius vexationibus fatigare. Sed omnia integra conserventur eorum, pro quorum sustentatione et gubernatione concessa sunt, usibus omnimodis profutura. Sane Xenodochia sive Prochia in occidentis partibus penes Burgum S. Egidii, Astense, Pisani, Barum, Ydrontum, Carentum, Messanam, Ierosolymitani nominis titulo celebrata in tua vel successorum tuorum subiectione ac dispositione, sicut hodie sunt, in perpetuum manere statuimus. Si qua igitur in futurum ecclesiastica quilibet secularisve persona hanc nostre constitutionis paginam sciens contra eam venire tentaverit, secundo tertiove communita si non satisfactione congrua emendaverit, potestatis honorisque sui dignitate careat, reamque se divino iudicio existere de perpetrata iniquitate cognoscat, et a sacratissimo corpore et sanguine Dei et Domini redemptoris nostri Iesu Christi aliena fiat, atque in extremo examine districtæ ultionis subiacet. Cunctis autem eidem loco iusta servantibus sit pax Domini nostri Iesu Christi, quatenus et hic fructum bone actionis percipiant, et apud districtum iudicem premie eterne pacis inventiant. **AMEN.
